




Over 2,000 children find themselves in foster care in New Mexico on any given day because of parental abuse or neglect. The children find themselves facing new challenges: living in other people's homes, moving from home to home or living in group homes.

Here are some of the ways in which you, our donors, make a difference for these children:

The Magic Kingdom: We happily bought tickets to



Disneyland for six girls, ages 5 to 13, who had been placed in the same foster home. The family takes their grandchildren and their foster children to Disneyland every year and covers as much of the costs as they can afford. Your donations gave six very excited young girls a trip to

Disneyland they will always remember.

A fresh start: In the middle of the school year a young teen was moved to a new foster home and school. She played clarinet in the band but could not take her instrument with her. She did not want anyone to know she was in foster care. Her Court Appointed Special Advocate (CASA) contacted NMFFC and this young woman had her own clarinet within one week of enrolling in her new school.

A vision for the future: Navajo Tribal Social Services requested assistance for a young teen living in a group home whose schoolmates were going on a trip to visit colleges. We paid the trip fees and provided spending

money. She was able to participate just like the kids whose expenses were covered by their families. She returned from that trip with a picture of herself going to college – a new vision for her.

A swimmer's ears: A five-year-old with cochlear implants loved to swim. A cover was needed to protect the device from the water and keep the child safe while swimming. We purchased a cover that allowed this little guy to swim as much as he wanted!

Set for success: An older teen in foster care was working on her GED in preparation for living independently when she turned 18. One of our former scholarship recipients was this young woman's counselor and knew about our awards program. The counselor applied to NMFFC for assistance to help this young woman obtain her GED, which we gladly provided.

A special companion: An emotional support animal was recommended for a young boy with special needs. His foster parents identified a dog through a group here in New Mexico and asked if we could assist with



training costs, which we did. They reported later that the dog had a very calming effect on the child. Talk about two happy campers!

A family trip: A foster family had a family trip planned. They wanted to include a child who had

In 2017 and 2018, your donations purchased bikes for kids simply so they could be kids, but you also purchased bikes for some very special situations:

- a preteen's therapist determined that the young person would benefit from a bike with training wheels and other safety equipment
- a youth in a residential shelter needed a bike so he could get to his high school
- a ten-year-old child in treatment foster care needed a focused physical activity
- a pre-diabetic youth with medical and emotional issues needed a bike for exercise and an energy outlet.

Each of these children received a bike because you care.

Supporting Older Youth

Youth who have been in foster care often lack a support system to help them transition into adulthood. Because of its donors, Friends has helped fund activities that bring these youth together to learn, to share ideas, to laugh, to celebrate – to build community.

• Independent Living Youth Conference

Planned by youth, the annual Independent Living Youth Conference brings together older and former foster youth from around the state. In 2018, a grant from Friends helped the planners bring in a keynote speaker who addressed topics close to the hearts of these youth: love, heartbreak, and "the ongoing battle between closing yourself off to the world or choosing to stay open to love." Friends also helped with funding in 2017.

NMCAN Scavenger Hunt

The nonprofit NMCAN pairs young people who were in foster care with adult mentors. It organizes an annual scavenger hunt that brings the youth and mentors together for a fun day of exploring the community, culminating with lunch and an awards ceremony. Friends helps with the expenses for these events.

Festivus

The holidays can be a hard time for young people who have been in foster care. In both 2017 and 2018, Friends helped with **Festivus**, an annual gathering organized by NMCAN that brings together youth and their chosen family, friends and mentors to enjoy a holiday celebration unique to them and their community of people who support them.


The goal of New Mexico Friends of Foster Children is to help foster children succeed in their education and engage in activities that will make a difference in their lives.

NMFFC Scholarships Continue to Reach Youth Statewide

Our scholarship program is flourishing. Young people who were once in foster care are seeking and using these scholarships to help them with their expenses as they work toward their college degree or training certificate.

Thanks to all of our donors, we were able to award 40 scholarships in 2017 and 2018.

The applicants awarded scholarships continue to come from communities around New Mexico, including Farmington, Mora, Santa Fe, Ohkay Owingeh, Albuquerque, Laguna Pueblo, Roswell, Hobbs, and Las Cruces. Most had been in foster care through CYFD but several had been in the custody of a tribe or pueblo. Foster care didn't necessarily mean one foster home but could mean multiple placements, including group homes. The vast majority



aged out of the system and were on their own; a number had been adopted, some while in their late teens. The young people had all suffered hardships growing up; their perseverance was remarkable to behold.

Applicants were going to CNM, ENMU Roswell, New Mexico Junior College, Doña Ana Community College, UNM, and NMSU. Two were going to music school in Colorado while one was going to Notre Dame in Indiana. Regardless of their primary focus, most of these young people are determined to do something that will help children and youth who grew up as they did.

We continue to see scholarship recipients who became counselors or social workers and are now helping other youth access funds from Friends to help meet their needs. In 2018, we were excited to see a letter of recommendation for one of our scholarship applicants come from a former scholarship recipient, who went to work for CYFD after college. We also have a scholarship recipient who is slowly but surely getting herself through college while she works as a counselor for a group home. We've written about how she applied to NMFFC for assistance to help one of the teens obtain her GED. It is so rewarding to see our recipients use Friends as a resource to assist others.

recently been placed in their home. We helped cover the additional cost so everyone in the family could go on vacation together – as a family – an experience that is often new to children coming into foster care.

Maximizing resources for kids

One of our goals is to maximize your dollars by working with others to meet the needs of children and youth in foster care, needs that might not be met without others partnering with NMFFC.

A lovely example of this type of collaboration involves a teen who has a passionate interest in pursuing a medical career. She was able to attend a specialized medical career training camp, thanks to the efforts of several people and groups, including NMFFC, working together to collect the needed funding.

We coordinate with CYFD and others to find the best solution for each child who comes to our attention. A youth attending a special camp needed his motorized chair to participate fully in camp activities. NMFFC and his case worker partnered to access existing funds to pay for a special van designed to transport motorized chairs. We did not provide funding but we helped find a solution.

Helping Kids Be Kids and Students Be Successful

Every dollar that Friends spends to make awards to support young people who have been in foster care is provided by our donors. The generosity of our donors never ceases to amaze us but we had some exceptional surprises in 2017 and 2018. These unexpected gifts added \$46,000 to our fundraising:

Early in 2017, Dr. Andrew Hsi of **A Step Ahead** announced that this nonprofit group was making a substantial donation to New Mexico Friends of Foster Children. What attracted A Step Ahead to Friends was its scholarship program – Friends' effort to support young people who have experienced foster care and who are going to college or technical school while often struggling to make ends meet.

Shortly after receiving the news about A Step Ahead, our program manager received a phone call from the **Notah Begay III Foundation**. Mr. Begay had chosen New Mexico Friends of Foster Children to be one of three local nonprofits to receive donations from the New Mexico Grande Slam, the signature golf tournament that the Foundation organizes annually to raise money for its initiatives for kids. At the pre-tournament dinner, Mr. Begay said the beauty of Friends is that it keeps things simple -- it's about helping foster kids be kids.



The owners of **Sadler & Son Monument Works Co.** in Hobbs heard about Friends from one of our board members and promptly wrote a very generous check to our program.



In early 2018, we received yet another wonderful surprise. The parent organization for **Blue Cross Blue Shield of New Mexico**, through its Management Steering Committee, awards grants to organizations making a difference in their communities in the states they serve. Friends was honored to receive the award for New Mexico.

Later in 2018, the Albuquerque Community Foundation,



Junior League of Albuquerque Charitable Endowment Fund, awarded a grant to Friends for two \$1,000 educational assistance awards (scholarships) specifically for young people who have experienced foster care. Two youth residing in Albuquerque at the time of their applications received these awards.



And as 2018 turned into 2019, the board of directors for the **Center for Action and Contemplation** informed us that it was

making a gift to New Mexico Friends of Foster Children to support Friends' mission and vision.

We wish to express our heartfelt thanks to each of these organizations for their compassion and their vision for the future of children and youth who have been impacted by abuse or neglect.

Announcing the Bouchard Family Scholarship

In 2018, the NMFFC Board of Directors created a scholarship in honor of Bebeann Bouchard, who brings many years of passion, dedication and work experience to helping children, youth and families survive and thrive in their homes and communities. We are particularly grateful for her work with Friends. Bebeann has volunteered with Friends since it was founded, not least as a member of the Awards Committee, where she read numerous scholarship applications that made her deeply concerned that we support these remarkable young people. It was she who brought her concerns to A Step Ahead, a nonprofit organization with which she had been involved for years.

The first Bouchard Family Scholarship was awarded in 2018 to Ivanna Cubero, who aged out of the foster care system and was working toward her second Associates degree, a degree in welding technology. Despite the challenges she faced growing up, this motivated and talented young woman won art awards in high school, attained Dean's List status in college, and was obtaining the skills she needed to become a welder so that she could support herself as she pursued her dream of an advanced degree. She planned to use the scholarship to acquire the equipment she needed for her courses.

The recipient of the Bouchard Family Scholarship for 2019 has been selected and will be featured in our next report.
